New Business

CITY OF GIG HARBOR PUBLIC WORKS DEPARTMENT, GIG HARBOR, WA 98335: Gig Harbor Commercial Homeport, PL-SDP-22-0005, PL-SPR-22-0007 & PL-SEPA-22-0014. The proposal is to construct a commercial fishing homeport dock system at Ancich Waterfront Park, including a 280-foot main walk float, 15 60-foot finger floats, two 80-foot finger float, an 80-foot gangway, and installation of steel guide and fender piles. The project also includes utility extensions with a sewer pump-out station, removal of the existing Jerkovich Pier and creosote piles, and shoreline mitigation improvements such as beach nourishment and stormwater outfall restoration. The proposal would result in a net overwater coverage increase of approximately 4,852 square feet.

Speakers will be allotted 3 minutes per individual. Comments shall be made, first giving the speaker's name and address. Anyone making "out of order" comments may be subject to removal from the meeting. Written comments may be submitted to the Hearing Examiner by email at PlanningComments@gjgharborwa.gov.

All speakers shall be courteous in their language and deportment and shall not engage in or discuss or comment on personalities or indulge in derogatory remarks or insinuations with regard to the Hearing Examiner, or any member of the staff or the public.

There will be no demonstrations during or at the conclusion of any public comment. These guidelines are intended to promote an orderly system of holding public hearings to give every person an opportunity to be heard and to ensure that no individuals are embarrassed by voicing their opinions.
