3. **Review of 2023-24 Work Plan** – The commission reviewed and discussed their 2023-24 Work Plan, including the Harbor Arbor Art project.

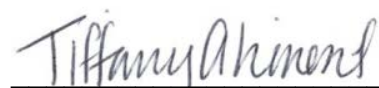
The commission would like to invite Parks Manager Jennifer Haro to their September meeting to receive an update on the Sports Complex and Crescent Creek Park Master Plan.
