New Business

1. **THOMAS LERCH/JOHN LEE EUGENE, 9167 NW KAISER RD, PORTLAND OR, 97231: Ancich Private Dock**, (PL-SDP-23-0005, PL-SEPA-23-0009)
CONTINUATION OF JULY 16, 2024: The applicant is proposing to remove and replace the solid decked pier, ramp, piling and floats and install a new pier, ramp, float system with up-to-date environmental standards in a new configuration. The total existing square footage is 8,970,

the proposed square footage is 8,186, a reduction of 784 square feet. The applicant is proposing to remove a total of 1,890 cubic feet of concrete.

The proposed project will bring the materials up-to-date and install aspects including grating with a minimum of 61% open area on 100% of the pier and ramp and 50% of the floats. It will remove the creosote treated pilings and replace it with galvanized steel. Light penetrability and fully encapsulated floatation will bring the dock up to date. The site is located at 3615 Harborview Dr., the site is located on the north side of Harborview Drive and boarding on the north side of the Ancich Waterfront Park. Sec 05, Tw 21, R 2. BUCHOLZ BOATLIFT INSTALLATION, (PL-SDP-23-0004, PL-SEPA-23-0008).

The proposal includes the installation of a 10,000lb boat lift just waterward of the existing bulkhead allowing a small vessel to be raised to the level of the deck for safer access to the vessel. The boatlift shall be supported using 4 10-inch diameter galvanized steel piles.
