CITY OF GIG HARBOR PUBLIC WORKS DEPARTMENT, GIG HARBOR, WA 98335:

Lift Station #1A Sanitary Sewer, PL-SCUP-25-0001. Project proposal is to upgrade Sanitary Sewer Lift Station No. 1A to improve reliability and service for the community. The work includes building a new underground wet well with modern pumps, along with a new approximately 600-square-foot metal building and improved driveway access. The new facility will house essential equipment such as water service connections, valves and piping, a backup diesel generator, odor control systems, and electrical controls to support safe and efficient operation.

Speakers will be allotted 3 minutes per individual. Comments shall be made, first giving the speaker's name and address. Anyone making "out of order" comments may be subject to removal from the meeting. Written comments may be submitted to the Hearing Examiner by email at PlanningComments@gjgharborwa.gov.

All speakers shall be courteous in their language and deportment and shall not engage in or discuss or comment on personalities or indulge in derogatory remarks or insinuations with regard to the Hearing Examiner, or any member of the staff or the public.

There will be no demonstrations during or at the conclusion of any public comment. These guidelines are intended to promote an orderly system of holding public hearings to give every person an opportunity to be heard and to ensure that no individuals are embarrassed by voicing their opinions.
